

## DR HANS EINSTEIN HIGHLIGHTS COCCI CONFERENCE

For 53 years, the Cocci Study Group (CSG) has provided an opportunity for health care professionals, epidemiologists and scientists interested in coccidioidomycosis to gather and learn from one another. This year the meeting was held on the campus of Cal State University, Bakersfield. Moderated by Dr. Antonio Catanzaro, CSG President, the day was packed with the presentation of scientific papers on topics ranging from cocci in the soil to cocci in living bodies.

A highlight of every conference is the Saturday evening dinner which allows casual exchange of ideas and discussion of the materials which have been presented during the day.

This year, the conference participants were presented with a special treat. World recognized cocci expert Dr. Hans Einstein reviewed the history of cocci research.

In a tour de force presentation accompanied by power point slides, Dr Einstein began with the first cases diagnosed, continued with the stories of William Offuls, C.E.Smith, Myrnie Gifford, William Winn, and others who contributed during the early years, and swept on describing early treatment efforts, the development and testing of a first vaccine, concluding with his

perspective on the current vaccine effort and the need to ensure that promising research is supported.

Dr. Einstein received a standing ovation for the presentation and for the friendship and leadership he has provided the cocci community.



## VACCINE PROJECT RESEARCH PUBLIC FORUM

While vaccine development efforts can be traced back to the 1950s, it was the formation in 1995 of the Valley Fever Vaccine Project, which cooperatively links researchers in several universities with donations from individuals, as well as grants from local, state and federal government sources that has provided a focused and forceful boost.

## Cocci Study Group Proceedings Available ONLINE

The Coccidioidomycosis Study Group first met as a group in San Francisco 1956. A complete list of meeting dates and locations is available at the Valley Fever Center for Excellence website [www.vfce.arizona.edu](http://www.vfce.arizona.edu). All available meeting proceedings can be accessed at this website, the earliest posted being 1983.

For those with an interest in the topic, the abstracts are a treasure trove of facts and theories, as well as a quick stroll down memory lane. The names of all the scientists in the photo below will be seen as authors and presenters, as well as many others who have contributed over the years..

Most articles are highly technical and of interest only to the medical and research professionals for whom they were written, but some are of interest to the layperson as well. How about a followup on coccidioidomycosis cases resulting from the California Central Valley dust storm of December 1977 submitted by D. Pappagianis and S. Lindsay in 1983.

In 1996, T.R.Larwood submitted a report of 58 years of Coccidioidin skin testing in Kern County documenting a drop from 96% probability of a positive skin test in 1937 to 40% by 1996.

The 54th annual Coccidioidomycosis Study Group meeting which will be held in Surprise, Arizona Saturday, March 27, 2010, is sure to add even more items of interest to the scientists paying attention to Valley Fever!

## What's happening with the science?

Currently, the Project is sponsoring efforts to address the solubility of the Ag2/PRA-CSA vaccine, and is evaluating a new adjuvant.

Dr. Jennifer Laurence, of the University of Kansas, is manipulating the CSA portion of the vaccine by substituting different amino acids for cysteine molecules in the CSA. Cysteines have the property of cross-linking with other cysteines, often causing cross-linking and aggregation between different molecules. But putting different amino acids in place of the cysteines, it is hoped that the molecule will become soluble, yet will retain its ability to serve as a good vaccine.

Once enough of the soluble material has been produced, Dr. John Galgiani, of the University of Arizona, will evaluate it in comparison to the un-modified vaccine in mouse experiments to verify the activity of the preparations.

Dr Galgiani is also currently evaluating a new adjuvant in mouse experiments. As has been reported in previous issues of the newsletter, the availability of good adjuvants for use in cell-mediated diseases (like Valley Fever) has been a limiting factor in the efforts to advance the vaccine. Fortunately, a new adjuvant that has been evaluated in Phase I trials in humans has been made available to the Project for testing.

If the experiment now in progress confirms that the adjuvant provides sufficient potency to the vaccine, then additional experiments can be performed to optimize the combination of the new adjuvant and the vaccine.

Lastly, the Project has received proposals from four of the original research investigators of the Project for new antigens that could be added to the existing vaccine, or replace the existing vaccine if they prove more potent. These research efforts will be funded from the new funding made available by the State of California, through the Department of Public Health, and greatly enhance the ability of the Project to advance the vaccine into development.

## VALLEY FEVER IN THE PUBLIC EYE

The illness of Arizona Diamondback's outfielder Conor Jackson has served to keep "our" disease in the news for several months in Arizona and among fantasy baseballers throughout the nation. Only a few years ago, the idea that fantasy baseball could contribute to educating folks about the potentially serious impact of Valley Fever would have been considered bizarre, at least by this newsletter editor.

Now an even more bizarre situation is developing with entertainment industry publications reporting that convicted murderer Phil Spector is terrified by a proposed transfer to Coalinga State Prison because 16 inmates have died of Valley Fever there in the last 4 years. His "frantic" wife, Rachelle Short, says "they are sending Phil there to die" according to comments quoted in the New York Post's Page 6 celebrity news. Sharon’s struggle to recover is told at their website, [www.valleyfeversurvivor.com](http://www.valleyfeversurvivor.com). Initially she was given antibiotics but continued to get worse. The disease nearly killed her.

David nursed Sharon night and day through her illness, and when she decided to become an advocate for public awareness he was eager to help.

They built the website from scratch and are constantly refining its message and adding to it. They have helped establish support groups in Arizona. They work hard to provide useful information to victims, and have provided email or phone assistance to thousands.

The book is a major product of their work together and is the first and only book of its kind. It is a compilation of information about the disease as well as personal stories of victims. The personal stories included are particularly meaningful to those who are currently suffering from the disease, and their families.

You will find very practical information such as what you need to know before you see a doctor, and a 465 word glossary of medical terms to help you understand what the doctor says!

first public assemblage of the researchers to discuss their progress and challenges, and determine how to proceed since the Bakersfield-based campaign was launched.

Although efforts over the past 15 years have not resulted in the development of a vaccine to combat Valley Fever, researchers agreed that the project has yielded many benefits. Scientists are closer today than ever before to achieving their vaccine goal. In addition, much has been learned about the disease that improves treatment of infected people and that alerts the public to the presence of the disease.

Marcus Horwitz, a professor of medicine at the University of California at Los Angeles, who is renowned for his work on developing tuberculosis vaccines, applauded those who are supporting the Valley Fever vaccine project and the discoveries that have been made. He urged researchers and supporters to push forward with what he assessed as “cutting edge research.” He noted that “a tremendous amount of progress has been made.”

Obviously, without funding the project cannot keep moving head. We must look for increased corporate and foundation donations. Fortunately the State of California continues to invest in the future with \$1 million in the budget for vaccine research in fiscal 2009/2010. It would be great to see some State of Arizona and Federal money placed in the pot as well!



Dear Friends of the Vaccine Project,

We are proud to have helped sponsor the Valley Fever Vaccine Day held in conjunction with the Cocci Study Group meeting in Bakersfield in April 2009. The day was planned by Dr Hans Einstein, Dr. Tony Catanzaro and Dr. Tom Larwood. It was the first time to bring the researchers together in public forum to present their research and respond to questions.

When the day was done, we asked this question: we have spent a lot of money and don't have a vaccine yet; do we keep going or quit. One of those responding was Marcus Horwitz of UCLA who is very highly regarded because of his work on tuberculosis vaccines. Dr Horwitz was very plain in his assessment of the reports he heard during the day. He said the research being done is on the cutting edge and has shown more progress than he expected to hear. He said there are no guarantees in vaccine research, but that as a believer in vaccines he definitely felt we should continue, and that it appears to him we are going about it in the right way.

Also responding was Dr. John Galgiani, one of the project researchers, who spoke to the advantages he had found being able to work cooperatively on this project, rather than competitively. This approach he feels is responsible for many of the gains which the project has been able to make.

The Valley Fever Americas Foundation remains committed to continued support for vaccine research and development, and we look forward to continued support from the communities which suffer from this disease
